REGISTRATION AND PAYMENT INSTRUCTIONS

Please send a completed registration form **BY JUNE 23** but **DO NOT SEND PAYMENT** unless you are registering a spouse. The Iowa Department of Agriculture and Land Stewardship covers registration costs for Iowa Commissioners, Assistant Commissioners, State Soil Conservation Committee Members and IDALS-DSCWQ Staff.

Spouse registration fees should be made payable to National Association of Conservation Districts.

DO NOT SEND or fax registration forms after JUNE 23. To attend after JUNE 23 you will register on-site as a walk-in. There will be a \$75 late fee for on-site walk-in registrations after JUNE 23. The individual Commissioner or District will be responsible for charges incurred for on-site walk-in registrations. Conservation Districts of Iowa and the Iowa Department of Agriculture and Land Stewardship will not cover late fees for on-site walk-in registrations.

REMEMBER to select either the soil health tour or water quality tour if you are completing a full registration.

Your confirmation is your receipt for the meeting; please keep it for your records.

HOTEL RESERVATION INSTRUCTIONS

Book your hotel room at Prairie Meadows Hotel right away using the information below for the evening of July 17. Book your hotel room for July 16, if necessary.

While your hotel rooms for the evening of July 17 and July 16, if necessary, will be paid for by the Iowa Department of Agriculture and Land Stewardship, you will need to provide a credit card to hold the room. The individual Commissioner or District will be responsible for the reservation and cost of overnight stays on July 18 after the conclusion of the tour at 4PM.

Cancellations must occur by 4PM prior to the day of check-in. The individual Commissioner or District will be responsible for cancelling and costs associated with unused hotel rooms in the event failure to cancel occurs. Conservation Districts of Iowa and the Iowa Department of Agriculture and Land Stewardship will not cover the cost of an unused hotel room should the Commissioner or District fail to cancel.
