We are not asking you to vote on the 2017 Proposed Policy Statement Handbook Changes during pre-conference voting. We are sending them to you at this time to review again. This was distributed and discussed at the 2017 Spring Regional Commissioner Meetings. Be prepared to vote to adopt these handbook changes during the CDI Business Meeting on Monday, July 17, 2017.

#### **Eligibility for Voting:**

1. Current SWCD Commissioners are eligible to vote on the ballot based on the dues paid in the fiscal year (2016 - 2017).

#### Requirements for Passage of Resolutions:

- 1. Resolutions that receive at least 60% of the votes for approval by the Commissioners voting will automatically be adopted with no further action at Annual Conference.
- 2. Resolutions that receive at least 60% of the votes for disapproval by the Commissioners voting will automatically fail with no further action at Annual Conference.
- 3. If a resolution does not receive the required number of votes in either the approval or disapproval category, it will be discussed or amended during the CDI Business Meeting on Monday, July 17, 2017.
- 4. A representative of the proposing district must be present at the CDI Business Meeting for any resolution that is to be considered for discussion/amendment at the CDI Business Meeting on Monday, July 17, 2017.

#### <u>Iowa Financial Incentive Program (IFIP) Funds Recall</u>

We believe that IFIP funds are instrumental for all districts in getting good conservation practices on the ground. Soil erosion and nutrient loss are an issue in all parts of lowa, and conservation practices are vital to all types of landscapes. However, some districts have a hard time utilizing these funds prior to the December 31<sup>st</sup> recall, other than on cover crops, no-till and strip-till. This is because of the early recall deadline.

CDI should recommend to the state that they revise the rules on IFIP funding to change the recall of funds date from December 31st to the last working day in March. This would give those districts more time to utilize their allocations for those local producers/owners that come in late in the year, or early in the following calendar year.

Explanation: Districts quite often have operators/landowners come into the office after harvest is complete or after the holidays when they have had time to look over their fields and determine if there may be a need to install a conservation practice. Unfortunately, we have to turn people away for cost share early in the year because of this rule. If they have to wait to get their projects started until the following fall or following spring, the possibility of them deciding not to go forth with the project is very real.

#### 2. Deny State Cost Share to Farmers who Fall Till Soybean Stubble

The Purpose of the voluntary nutrient reduction strategy (NRS) adopted by Iowa is to reduce the amount of nitrogen and phosphorus in surface waters by 40%. Phosphorus loss is primary associated with soil sediment leaving the field because of tillage erosion.

Be it resolved that CDI recommends the Division of Soil Conservation deny cost share to farmers who fall till soybeans stubble. Injection of manure and commercial fertilizer is permitted.

This will significantly reduce the amount of P reaching Iowa's surface waters and reduce the hypoxic zone in the Gulf of Mexico. The fall tillage does NOT allow the establishment of cover crops.

#### 3. <u>Limit CRP Waterway Enrollment to One Contract</u>

Grassed waterways are a vital conservation practice and have been used to control gully erosion on HEL fields since 1985. Producers that have never seeded down their waterways previously have been able to enroll these areas into CRP and receive annual rental payments indefinitely as long as the waterways are maintained and the contracts are re-enrolled. This is not fair to the producer that did the right thing years ago and created grassed waterways on their own initiative and thus will never be eligible for CRP. Re-enrollment of CRP waterway contracts also creates a high volume workload for field office staff. Many waterway contracts cover only a few tenths of an acre but still require the same amount of time and paperwork as large contracts.

CDI supports a change to the CRP rules to a "one and done" policy for grassed waterways, so that if an area is currently eligible for a CRP grassed waterway, it can be enrolled with incentives and annual rental payments for one contract term (10 years). It would not be eligible for re-enrollment. Any existing CRP waterway contracts would also not be eligible for re-enrollment beyond the current contract.

#### **Explanation:**

A "one and done" policy for CRP grassed waterways would still allow producers to enroll grassed waterways into CRP the same as current policy, but it would limit the CRP option to one contract period, which is fair to producers and is not an abuse of the CRP. If a waterway would need maintenance or reshaping in the future, the producer could apply for assistance through another state or federal program, or do it on their own.

#### 4. Erosion Control Restrictions for CP-42 (Pollinator Habitat)

The current CRP rules allow for up to 100 acres of CP-42 (Pollinator Habitat) per tract and it can be planted on any ground that is eligible cropland.

Much of the cropland in Northeast Iowa is very steep. While we believe the pollinator habitat has merit, it is a slow to establish ground cover and initially not a dense ground cover taking several years to establish. On highly erosive soils, this presents a soil erosion and thus water quality hazard.

We would propose that on any soils with slope category C or greater that the CP-42 pollinator habitat be limited to only plantings in strips up to 30 ft. wide and never exceeding 5 acres in size on any tract.

#### 5. Include Palmer Amaranth on the Noxious Weed List of Iowa

Palmer amaranth is a fast growing weed native to the southwestern United States and northwestern Mexico, and has spread east and north through a variety of pathways including contaminated seed, hay, livestock feed and agricultural equipment. It has developed resistance to multiple classes of herbicides and their different modes of action, making it very difficult and expensive to control. Palmer amaranth is a prolific seed producer. Up to 250,000 seeds can come from one plant. It is also highly competitive.

It has a fast growth rate of 2-3 inches per day and commonly reaches heights of 6-8 feet, greatly inhibiting crop growth. Reported yield losses have been up to 91% in corn and 79% in soybean in some states. The weed can also significantly increase production costs for corn, soybean, and other crops.

CDI supports the addition of Palmer Amaranth to the noxious weeds list of Iowa. Working in association with the Secretary of Agriculture, IDALS, and State Soil Conservation Committee we ask that Chapter 317.1 of the Code of Iowa be amended and Palmer Amaranth be included as a primary noxious weed.

The intent of the noxious weed law is to protect landowners from having their land invaded by weeds growing on adjacent land. The law gives each county the authority to order the destruction of weeds classified as noxious by the state. If the owner of the land fails to address the weed problem, the county can assess the owner a fine and control the weeds and charge the landowner for the costs of the control tactic.

Palmer amaranth, which can dramatically cut crop yields, has been identified in 49 counties in Iowa, nearly 10 times as many counties than at the start of the year (2016), said Robert Hartzler, an Iowa State University professor of agronomy.

"We have so much Palmer amaranth in the state, there's no doubt it will establish and move," Hartzler said. "It will have a significant economic impact."

CRP plantings in 2016 contributed to the increase of Palmer Amaranth throughout Iowa. Growers are encouraged to mow CRP acres the first two years of growth. Palmer Amaranth will be suppressed in CRP planting after year four. If included as a noxious weed, FSA can approve mowing of infected areas.

## 6. <u>Up to Two (2) Commissioners from One (1) Township in Each Soil and Water Conservation</u> District

Five (5) commissioners are elected from each County as Soil and Water Commissioners. It has become increasingly difficult to find interested parties willing to donate their time to lead the conservation efforts of their county. Conservation leaders are not always evenly distributed among townships in our counties. Often our best local Conservation leaders happen to live in close proximity to one another. In order to be able to utilize the best and most interested potential commissioners, we need to change the rules to have up to two (2) commissioners from one township in a Conservation District in the State of Iowa.

CDI should ask the State Soil Conservation Committee to work with IDALS-DSCWQ to change the rules to allow for up to two (2) commissioners from one (1) township.

Rural farming demographics have changed dramatically since authorizations of Soil and Water Conservation Districts in the 1940's. Many SWCDs are experiencing difficulty attracting potential commissioners for a variety of reasons: Aging farming population; there are fewer farmers every year, rural populations in general are decreasing each year, full-time farmers and farmers with off-farm careers have less time to devote to activities like SWCD Commissioners positions; counties with fewer townships due to the smaller physical size; and general lessening of interest in volunteering time for non-paid community work. While we agree that a diverse board made up of commissioners from different county locations is desirable and necessary, we propose that the current rules should be changed to allow for up to two (2) interested individuals located in the same township to be able to run for office and hold office simultaneously. There is no need to limit participation of potential commissioners to fill a vacancy just because an existing Commissioner lives in that same township. Therefore, to maintain the integrity of the Soil and Water Conservation District System in Iowa, we need to broaden the eligibility of interested applicants to our SWCD Boards. Limiting it to 2 commissioners from a single township still keeps representation below a majority votes of a District Board ensuring county wide representation while making it much easier to recruit to fill vacancies on the SWCD Board.

#### 7. Voting By Authorized Attorney-In-Fact:

CDI Bylaws allow for active Soil and Water Conservation District commissioners to vote by authorizing an attorney-in-fact to act on their behalf in the transaction of Association business (Section 3.2). This method is available to allow all commissioners to have a voice in the organization regardless of their work schedule, travel distance, and ability to attend a meeting.

CDI staff and board shall work together to develop a form for commissioners to appoint an attorney-in-fact to vote on their behalf, and guidance for implementing this section of the Bylaws. CDI should clarify voting materials to agree with this aspect of the organization's existing Bylaws and accommodate this option.

Explanation: Some commissioners have difficulty attending the CDI annual meeting for various reasons, particularly work schedule and travel distances. CDI Bylaws provides for those commissioners to be able to vote by appointing an attorney-in-fact. Appointing an attorney-in-fact requires a notarized form. Getting that form from an attorney may cost a district money, and multiple districts developing their own form could result in added work and confusion for CDI employees and volunteers. Having a standard form and guidance developed would aid in utilization of this option.

Section 3.2 Voting. Each active member shall have one (1) vote in the transaction of business of this Association. An active member may vote in person or by proxy executed in writing by an active member of his/her Soil and Water Conservation District, or by his/her duly authorized attorney-in-fact. An active member executing a proxy for a commissioner of his/her respective Soil and Water Conservation District must register the written proxy with the meeting's secretary prior to the opening of the meeting, or send by mail the written proxy to the secretary of the meeting five (5) days prior to the meeting date.
