### INITIATIVES OF INTEREST: Displaying a watershed map in your SWCD Office Henry, Lee, Van Buren and Jefferson SWCD Submitted by: Nathan Shelman, Lower Skunk River Watershed Coordinator



The Lower Skunk River Water Quality and Soil Health Initiative supports the Iowa Nutrient Reduction Strategy and the Iowa Water Quality Initiative by working with producers within the Lower Skunk River Watershed in Henry, Lee, Van Buren, and Jefferson Counties. The project demonstrates and accelerates the adoption of conservation practice that have been proven to be most effective in reducing nitrate-N and phosphorus-P in streams to ultimately end the hypoxia in the Gulf of Mexico . The Lower Skunk River Water Quality and Soil Health Initiative provides cost share assistance to implement practices of namely cover crops, bioreactors, wetlands, and grassed buffers. The project will also include educational efforts of field days, newsletters, and informational meetings.

In the Henry, Lee, Van Buren and Jefferson County field offices watershed maps are on display in all shapes and sizes. With the watershed being within four counties and over 135,000 acres the first question that farmers and landowners always ask is if they are in the watershed to qualify for the practices being offered. With the watershed being so large creating a map with the watershed's drainage area along with adding the townships and sections of all four counties was a necessity. The value of having a map makes finding out if the farmer is located in the watershed easy. Having a map to show them, and being able to interact with the farmer one on one to determine if the individual is in the watershed or where she/he is located in the watershed goes along way. Many times the farmer will know the township but doesn't know the section. With not all townships and sections being part of the watershed this allows for quick process of elimination to once again determine if the farmer is in the watershed area or not. With the watershed map being so large the farmer walking into the field office can have easy access to the map and can easily find where they are located if they know the location.

Getting a map printed off was easy. All that was done was to contact the Iowa Department of Agriculture (IDALS), Division of Soil Conservation (DSC) and Water Resources Program Planner Jackie Suckow. Jackie was able to print off up to a 36 x 48 map for the watershed at no cost at all. Districts who have watersheds within their counties should have a map on hand that is large and easy to follow for educational and outreach efforts. Having a map on hand allows the landowner an easy understanding on the area of where the watershed is located and where their farm is within the watershed.
