## Staff Spotlight

### Carlee Sabus - CDI Water Quality Specialist



Carlee has been with CDI since July of 2018. She is an Iowa native and grew up in the Des Moines area. Carlee graduated from Iowa State University with a focus in Natural Resources, where she gained a passion for conserving our land and water quality for current and future generations.

In the near future, CDI will add five new district planners. It is our plan that one position will be based in the Des Moines office and, in addition to some planning assistance, will serve as CDI's person in charge of communications. The other four positions will be located in the field to assist districts in determining their resource concerns and writing meaningful annual and five-year work plans. ## Soil Health Field Days



In 2019 CDI, through a grant from the National Wildlife Federation Cover Crop Champion program, sponsored or co-sponsored five Cover Crop Champion/Soil Health Field Days. Over 200 people attended these field days where they learned about the conservation benefits of cover crops and the benefits of soil health. Producers are beginning to understand that better soil health leads to higher profit through lower costs and equal or better yields than fields that are not cover cropped.



At one event, a producer mentioned that he had been doing soil testing on one particular field for seven years while he both no-till farmed the field and used cover crops every year. During this time, his organic matter in the field had increased by 1%. Not only does this increase the available nutrients in the field without adding commercial nutrients, this has allowed the producer to store over one ton of carbon per acre.

The Cover Crop Champion program is designed to target 'middle adopters', or those producers who are not the first to try cover crops but are those who have witnessed their neighbors try cover crops and then continue to use them. These middle adopters are the producers who will exponentially increase the acres of cover crops in Iowa when they fully adopt cover crop use.

## Resolutions

The Board of Directors will continue working to implement the eight resolutions that were approved by commissioners this year. Two of the measures, funding for education coordinators and the Iowa buffer requirement proposal, have already sparked a fair amount of discussion in Des Moines among lawmakers and state employees, and that is really the purpose behind the entire process.

## NACD

It is our intention to update you on how NACD policy and activities affect and support what we do in Iowa. Looking ahead, the NACD annual meeting will be held in Las Vegas in February 2020. President Carney is CDI's representative on the NACD Board of Directors and will participate in a series of Board meetings while at the annual gathering. Also, Iowa has a seat on the NACD Legislative Committee where resolutions from all states with national scope are debated, refined, and voted upon. CDI Vice-President Jack Boyer serves as an alternate delegate and will participate in the legislative hearings.

## Scholarship Fund

Last year CDI awarded a total of \$9,000.00 in scholarships to nine Iowa high school seniors. Scholarship money is raised primarily through the auction held at annual conference; this year the auction raised about \$7,800.00. We would like to continue funding the scholarship program at current levels, so if your district was not able to attend conference or you are feeling regrets that you did not spend more at the auction, CDI is happy to accept additional money. The chapters of the Iowa Administrative Code are the rules that implement the laws of our state. The section governing Soil and Water Resource Conservation Plans is Chapter 27-22 and defines what the plans are to entail. The work that went into the initial plans was very good but due to the required information, not the most exciting reading available to us in the conservation field.

As we prepare to assist you in writing updates to your five-year plans, we are creating a template that will offer the public we serve a better view of the important work Commissioners perform. We will move all of the statistics about the district and the current use of the land to the back of the plan and put the top priorities that you want to accomplish in the next five years on the front page. The public will no longer have to wade through all the details to get to what you believe needs to be done.
