President's Report

The day length and calendar indicate summer quickly coming to an end which, to me, seems unfathomable. It's hard to believe kids are already back in school, and choppers are starting to make corn silage in parts of the state. On our farm this week, we will be flying some cover crops on a couple of fields which will be grazed this fall and winter. I also have a good amount of rye and oats to clean, but I have been waiting for the germination test to come back before I start.

Last week was CDI's 80th Annual Conference. Overall, I felt the conference was great and I was pleased with how it turned out. I know I pumped up the speaker line-up last month, but they exceeded my high expectations. Nuffield Scholar and board member, Ruth McCabe, brought her infectious energy and set the tone for the day. During the business meeting portion of the morning, Iowa Ag Secretary Mike Naig spoke to the great work all of us commissioners are doing and talked about the expansion of the Working Lands Project. After lunch, Iowa Assistant Attorney General, Eric Dirth, gave legal updates to attendees. The information Eric presents is always useful and the Q & A portion of the presentation never lacks thoughtful questions and answers. The final speaker of the day was Adam Schneiders who is the Iowa DNR Water Quality Coordinator. Adam gave us a history of water quality from the early 1900's when industrial and municipal sewage was dumped directly into the rivers, up to present day. We are making progress and there is data to back that up, but we have much more to do. The DNR is using LIDAR to identify best management practices on Iowa's landscape, along with helping towns and cities improve and update their water treatment systems.

During the business portion of the day, the delegate body debated and voted on six resolutions that didn't get directly voted up or down in pre-conference voting. In total, 13 Resolutions were brought --Continued on Page 2

The resolutions guide our policy and prioritize talking points when talking to Legislators. T.C. Loving and I were elected to our 2nd term as vice president and president respectfully.

CDI Annual Conference was held August 25 in Ames

All locally elected Soil & Water Conservation District Commissioners from dues-paying districts were eligible to participate in this meeting, where important votes were conducted on CDI Resolutions. Members also conducted the election of the CDI President and Vice President, re-elected Sean Dolan as president and TC Loving as vice-president. During the business meeting, attendees heard from Iowa Secretary of Agriculture Mike Naig and received a legislative update from CDI lobbyist Jim Obradovich. A report from CDI Executive Director Dien Judge was also presented.

Commissioner's participation in this annual meeting is important to the success of our organization. CDI Resolutions passed at the annual meeting involving state

policies were taken to the Iowa Legislature and pushed by CDI's professional lobbyist.

Resolutions involving federal policy were advanced and moved through the resolutions process in the National Association of Conservation Districts.

Hydrostation Project Advances Real-Time Water Monitoring in Iowa

Bringing water data to every Iowa county

Lee Tesdell, a second alternate director for CDI, showcased his hydrologic weather stations, also known as hydrostations, on his prairie strip north of Alleman, Iowa, during an Iowa Flood Center and Iowa Geological Survey media event on August 7. The project is funded through congressional Community Project Funding supported by Representative Zach Nunn.

The primary purpose of the hydrostations is to help researchers understand, monitor, and forecast water-use conditions across Iowa. The stations are also intended to support a better understanding of the long- and short-term impacts of climate change on water, reducing risk from floods and droughts.

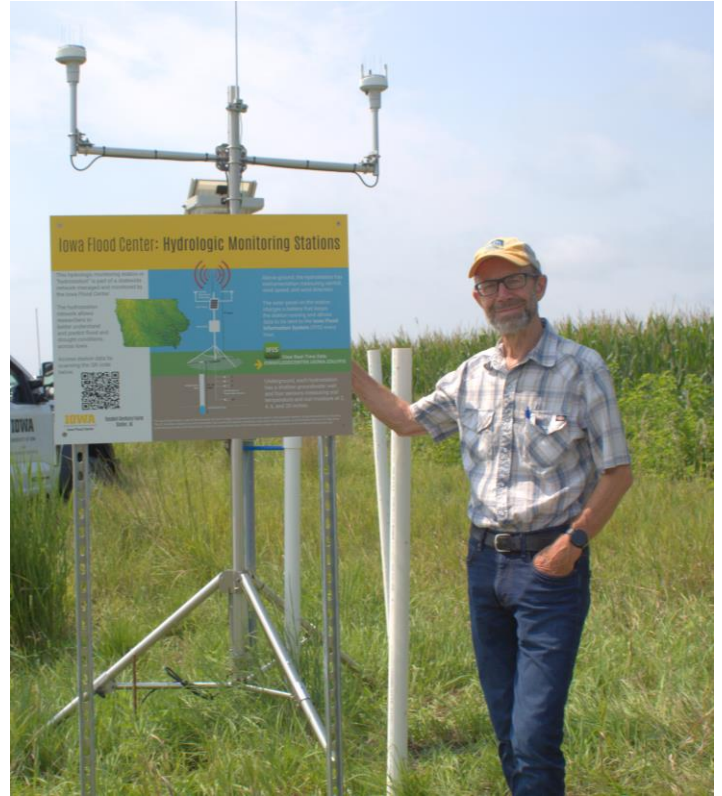

The Iowa Flood Center's goal is to establish one hydrostation in every county. Collected parameters include wind speed, wind direction, rainfall, shallow groundwater levels, soil moisture, soil temperature, and shallow groundwater temperature. The data are collected in real time, updated every 15 minutes, and provided at no cost to farmers or landowners. Farmers can use this data to better understand their soil.

They are being installed across southwestern Iowa within the next few months. If you want to be considered for a hydrostation please email giannini@uiowa.edu.
